AWAKENING CHURCH ANNUAL FINANCIAL REPORT OVERVIEW 2023 Fiscal Year (July 1, 2022 – June 30, 2023)

Awakening Church has continued to be blessed by God's provision and the generosity of our body of believers over this past fiscal year. The financial blessing has allowed Awakening to continue to press forward on our mission of "Awakening this generation to new life in Christ", and to pursue our vision of seeing people daily come to new life through salvation, functioning as an everyday church, impacting our local community in significant ways, and raising up the next generation of world changers.

The General Fund contributions for the fiscal year (\$1,977,757) fell 8.6% below our FY23 budget (\$2,164,649). The FY23 General Fund contributions represent an increase of 13.7% over FY22 actual General Fund contributions. Although contributions fell short of budget, the amount represents amazing generosity and a substantial growth in contributions.

Through God's providence and wise expense management, Awakening has ended FY22 with a General Fund Net Income (Retained Earnings) of just over \$99,000, which along with previous savings provides Awakening Church a substantial contingency fund to allow continued ministry in the event of a fiscal emergency. Awakening Church's Designated Funds did decrease slightly as giving to Benevolence and Missions Trip funds were less than was spent in FY23. Both funds still retain earnings at the end of FY23.

The Above&Beyond (A&B) fund has surpassed contributions of \$1,561,000 with \$320,000 given to compassion causes since the fund's inception maintaining the promise that 20% of A&B contributions would be given to compassion causes. The remaining funds position Awakening well for securing a permanent location as God enables us.


Awakening Church in FY23 has given over \$261,000 outside our doors to numerous compassion causes such as United Christians International (UCI) in Haiti, the Del Mar community, Called Up (ministry to local college athletes), Syria/Turkey Earthquake Relief, Highland Park shooting victims support, the Mission-Mexico (for school supplies), the Food Pantry (with City Team), and to the Intentional Ministries. Awakening has also dispersed over \$40,000 in Benevolence funds to those with acute financial need in both our church body and local community providing housing support, food, or medical payment assistance.


The Mission Trip fund was used to support Awakening's Youth Mission Trip to Mexico. With continued political instability in Haiti, Awakening leadership felt it unsafe to send a team to UCI, but rather used \$30,000 of the fund to help Haiti through continued UCI efforts.


The Benevolence fund has a strong, positive balance in anticipation of enabling Awakening to respond to fiscal emergencies in our body and local community.

The Compassion Projects fund has enabled Awakening Church to accept generous donations for specific Leadership Council approved compassion projects such as the Del Mar Giving Tree, Syrian/Turkey Earthquake relief (through World Vision), and support of the Highland Park Shooting Victims and their families.

Awakening Church looks forward to God's movement through his people and his extravagant generosity that we may "Awaken this Generation to New Life in Christ".









AWAKENING CHURCH FUND LEGEND

Definitions of fund types and usage

 GENERAL FUND – All income marked as General Fund, not designated, or received in exchange for some service or good accrues to the General Fund. General Funds may be used for any approved expense of Awakening Church.

The General Fund has both Unrestricted Funds and Restricted Funds. The Restricted funds are the Benevity Funds and the Compassion Project Funds.

- BENEVITY FUND Benevity income results from matching donations by donors' companies. These funds are restricted in their use by the matching organization in that they cannot be used for any proselytizing purpose.
- COMPASSION PROJECTS FUND CP funds are used only for Leadership Council approved specific compassion projects and provide a means to give directly to those projects during their specified times.
- DESIGNATED FUNDS Awakening has three designated funds: Above&Beyond, Missions Trip Fund, and Benevolence Fund
 - **ABOVE&BEYOND** funds for the acquisition and outfitting of a permanent location.
 - MISSIONS TRIP FUND funds for mission trip support, primarily to Haiti.
 - BENEVOLENCE FUND Funds to provide for the basic necessities of life to needy persons. This would include food, clothing, shelter, medical care and other types of assistance to the poor or destitute with preference to those who are part of the Awakening Church body.

Note: For annual reporting purposes, income is recognized when credited to an Awakening account and not when it is given. Expenses are recognized when they are initiated.
